

# "Inexpressibly Grand"

It's easy to take things for granted (or "granite" on Donner Summit – an inside joke among the local geological cognoscenti). We are surrounded by inexpressible beauty and opportunities. In 1846 Edwin Bryant, standing on Donner Summit said, "The Alps, so celebrated in history, and by all travelers and admirers of mountain landscape, cannot, I am satisfied, present scenery more wild, more rugged more grand, more romantic, and more enchantingly picturesque and beautiful.... The view [from

Donner Summit] is ... in expressibly comprehensive, grand, and picturesque. After congratulating ourselves upon the safe achievement of our morning feat [climbing up Donner Pass], and breathing our mules a few minutes, we proceeded on our journey." Parenthetically, Mr. Bryant's mule had just slipped and gone somersaulting down the Pass. Bryant and friends were afraid that the mule's career as a beast of burden was at an end but that could have been a sad story and since this is a family newsletter, you know that it can't be true. The mule got up, shook itself off, and proceeded on the journey. You can sleep well.

Our community recognized the nature of Donner Summit and contributed almost four million dollars to the purchase and preservation of the

surrounding 3,000 acres. If you are new to the community, you can see the evidence of the community's participation on hundreds of cabins, which display the brown plaque (see page 4).

One small part of the 3,000 acres is Rowton Pk. on the southeast side of Serene Lakes and above the intersection of Soda Springs Rd. and Serene Rd. The traffic in summer has increased over the last few years. Not many people visit in winter, however. Some people do follow the groomed ski trails to Razorback and then up to Rowton Pk. but almost no one goes up the ridge from the benches that sit at the junction of Bogus Basin and Jack's Jump ski trails. The route requires snowshoes or some form of backcountry skis but it's special and worth the effort. The view to the south is "is...inexpressibly comprehensive, grand, and picturesque" down in to the Royal Gorge, over to Snow Mtn, Palisade Pk. and Devil's Pk.

There will be a number of issues on the agenda, including the status of a proposed cell tower in Serene Lakes; whether the community is safer after the propane upgrades in Serene Lakes over the past three years; update on the traffic situation in Serene Lakes; update on revisions to the Green Sheet; whether SLPOA should ask SLCWD to allow it to set aside the Sunset cove area [the area along the lake immediately north of the old lodge building – ed.] for a walking trail and dog use; and, an update on trail use in TDLT areas this past summer, including how mountain bikers and hikers got along. We will also devote time to planning

winter activities including winter activities for kids' and adults. We will also get a report on how the ski areas are handling traffic as it affects our community. If you have had any experiences or ideas about this issue or any other issue you think is important to our community, feel free to send comments to our administrative assistant, Linda Cashion. Her email address is AdminAssistant@slpoa.com.

Following the Board meeting there will be a community potluck at Earl and Cathy Pierson's home on Acorn [#7918 – ed]. Plan to attend to meet your neighbors and fellow mountain lovers.

Now that it is winter, we need to be safe on the streets. Try to walk at the side of the road against traffic and, please, make sure your dogs are on leash when walking them around the lakes. With the snow cars can no longer stop on a dime and, often, visibility is low. We don't want any tragic accidents.

Has anyone else noticed there have been no blackouts so far. Kudos to PG&E for their work in preparing for winter. I hope by the time you read this newsletter we still haven't had any electrical outages.



Mr. Himelstein, engaged in an appropriate winter event with his friend, Cuzco. Loyal readers will know that George Lamson has an inexhaustible supply of photographs of which this is one. Closer in though, are the rock formations deposited when the Sierra were not the Sierra we know. Volcanic conglomerate flowed from what is now Nevada, west. Later the Sierra rose pushing the 30 million year old deposits to over 7,000 feet in elevation. Erosion now exposes the hoodoos (towers of rock such as to the center right of the arch in the picture here), cliffs, and a natural arch. Atop, stand the venerable Sierra Junipers (page 1), some of which are more than a thousand years old.

If you want to get to the ridge, go uphill directly behind the benches at the intersection of the Jack's Jump and Bogus Basin ski trails. Head for the ridge, which is to the right or south, and then walk up along it. The first hoodoo is a wide one. Just past the second hoodoo (center right of the picture here) make sure you are on the ridge and look over the side. There's the natural arch and Devil's Pk. in the distance. That's the view here.

The gnarled trees in the neighborhood are the Sierra Junipers. If you want to read more about the junipers, go to the Historical Society's website,


David retired earlier this year and Julie beat him to it by a few years. They sold their cabin and are enjoying a much expanded travel calendar. Chris continues to work for Cal Fire at the NorCal Command Center.

This author noted that the newsletter targets 1100 readers. There will be a corner of sand at the beach, under the pine tree (next to the recycle bin) that will always look a little empty without a certain set of Tommy Bahama chairs and a comfy quilt.

### Proposed S.L. Cell Tower Dick Simpson

About a year ago Epic Wireless Group, on behalf of Verizon Wireless, approached the Water District (SLCWD) with a proposal to improve Verizon's cellular telephone service in Serene Lakes by erecting a 'monopine' tower in the meadow south of the Serene Lakes fire station. Community members have since expressed concerns. Owners of cabins near the site are concerned about visual impact, and noise, and other issues. They have met with both the Water District and SLPOA boards. The SLPOA Board appointed a committee in October to investigate the issues. The committee has carried out a series of cell service measurements across around Serene Lakes, investigated possible alternate locations, and looked at alternate technologies.




Figure 1 (left): Stippled pattern, Red, indicates current line-of-site Serene Lakes cell coverage from Donner Ski Ranch using the application http://heywhatsthat.com. Cell services use microwaves which bend slightly over ridges and around corners to some extent, so measured coverage is somewhat better than line-of-sight. Figure 2 (right): Stippled pattern Red indicates line-of-sight coverage from the proposed tower behind the fire station (larger yellow white dot); the new tower should fill Verizon coverage gaps. Both images kindly provided by George Lamson.

**Current Conditions:** An on-line application can be used to map line-of-sight coverage from different locations. Figure 1 shows line-of-site coverage in Serene Lakes from a presumed cell tower at Donner Ski Ranch. Committee measurements with Verizon, AT&T, and T-Mobile cell phones are consistent with Figure 1. The northwest corner of Serene Lakes is reasonably well served from Donner Ski Ranch, but most of the community is shielded by 'Forest Service Ridge' on the east. T-Mobile, which operates from the tower at Soda Springs Mountain Resort, has the best measured local coverage though the pattern is similar to Figure 1.

Alternatives: Alternate sites are difficult to find because carriers want road access, electrical power, and (preferably) a nearby fiber cable for connecting into their service networks. A site at Royal Gorge's Summit Station appears equally feasible to the fire station meadow location; but Verizon has already explicitly rejected it. The fiber requirement makes a distributed antenna system (half a dozen less conspicuous 'nodes' scattered around Serene Lakes) more costly; home-scale 'nodes' have typical ranges of only 100 feet.

**Future:** The debate continues, currently only involving Verizon and SLCWD directly. The cell committee will continue to research these issues. For more information (including summary maps showing measurements for Verizon, AT&T, and T-Mobile), send an e-mail request to hut.coord@yahoo.com.

## Dark Skies - Carole Raisbeck

One of the greatest pleasures of life here at the Lakes is to step outside your cabin, look at the big night sky and watch those incredible stars .

Away from the city lights we are able to search for falling stars and bright planets, pick out constellations and even trace the paths of orbiting satellites ---what a thrill.

But this show happens only in the dark. Sadly, our dark skies have been diminishing as the number of outdoor cabin lights increases in our community,

In an effort to preserve the character of our night sky the SLPOA Board of directors is asking that homeowners take affirmative measures to minimize outdoor lighting.

What about exterior lighting for the snowplows and blowers, you might ask? Placer County Road Maintenance Department says lighting is NOT required, but a minimum amount, such as lower voltage motion sensors, or even little Christmas lights, can be helpful, especially on newer cabins that are not yet familiar to the operators.

Here are the steps you can take to help preserve our wonderful evening views.

1. Replace the sodium and mercury vapor lamps as they are overkill for the amount of lighting required. Unless they are installed with a lot

of shielding they spill into the night sky and shine into you and your neighbors' windows.

2. Put your outdoor lights on a motion sensor. Indeed, the California legislature is considering a bill requiring all new construction to be fitted with motion sensors for outdoor lighting in an effort to save energy.

3. Do not use exterior lighting fixtures where the source, i.e. the bulb, is visible from neighboring properties. Consider using 30W reflector bulbs (lengthening extensions are available), or fixtures with solid covering on the sides. In effect, the light should point down or reflect back onto your cabin, not shine out across the street. Carole Raisbeck at 426-0629 and Ann Bowles at 426-0690 have a supply available, \$3.00 for 30W bulbs and \$6.00 for an extension.

4. Use lower voltage bulbs.

5. Reach out to your neighbors and politely explain why they should comply.

Ask your family your friends, and your renters to please turn off those outside lights as quickly as possible. It will save energy, money, and the beauty of our night skies.

The overall season standings ended with the following top five racers (who raced in all three races):









Here in the SLPOA Ice Lakes News offices we take our responsibility seriously to present useful local information. One day while reading the <u>San Francisco Chronicle</u> prior to a heavy day in the SLPOA news offices, the <u>Ice Lakes News</u> staff came across an article about discovering local earthquake hazards. Naturally, the first inclination was to plug in Serene Lakes. After all, the USFS says there can be no more Van Norden Lake because of the earthquake hazard posed by the 50 acre feet of lake that the State will allow.

Just what is the earthquake danger in the vicinity?

Temblor.net, produced by a retired USGS fellow, provides local earthquake hazard information including the readings of recent earthquakes in the area. The map above, which shows better in color (SLPOA.com) shows nearby faults. Clicking on green dots presents data on recent earthquakes. Two weeks and one month before deadline there had been two earthquakes about 10 km from Serene Lakes. One measured .3 on the Richter Scale and the other, .4.

To do your own search, go to http://www.temblor.net. If you'd like to carry the app around with you to amaze your friends, then try http://beta/temblor.net in your phone's browser. In an Android, tap the menu and then 'save to home screen.' In an iPhone or iPad, tap the 'upload' icon at the bottom center of the screen, then the 'Add to Home Screen icon', and tap 'Add' in the upper right.


# Local Chef Review Kirke Hasson

Scott hit the mark again on December 29."




# I Thought I Was Special




I was very pleased with myself and chortled about it for some days until I shared the experiences with neighbors. It turns out the bobcat has been seen by lots of people.

#### **GREENBELTS** in Serene Lakes

Little known to most Serene Lakes residents is that there are greeenbelt areas all around the "Serene Lakes" subdivisions which, although the specific areas belong to the property owners on which the greenbelt areas are located, allow access to everyone, offering corridors for travel and recreation. There are some rules that go with the greenbelt areas which you can see here and which come from the subdivision maps filed at the County. If you want a full discussion of greenbelts go to the Spring, '07 SLPOA newsletter on the SLPOA website. There you will find a good article by Martin Bern.

The "Ice Lakes" and other subdivisions not named "Serene Lakes" have no greenbelt areas. The Ice Lakes subdivisions were developed before the idea arose and the other subdivisions are maybe too small.

The Serene Lakes subdivisions do have greenbelt areas allowing access and George Lamson has taken the actual subdivision maps and filled in color to show the greenbelts in Serene 1&2. If you have only the black and white version of the map (you are looking at a hard copy and not a digital version) the greenbelts are the solid shaded area on the map. Maybe in the next newsletter we'll have a map of the other Serene Lakes subdivisions' greenbelt areas. A picture is worth a thousand words so we'll let the map speak.

#### From Martin Bern's article in 2007:

"The CC&R's contain restrictions on the use owners may make of greenbelt areas. For example, greenbelt areas, which are located on privately-owned lots, can be accessed by landowners in Serene Lakes, but not by the general public. These lot owners are permitted to use greenbelt areas only for "ingress and egress," --- coming and going. This clearly would not include temporary or permanent uses, such as boat storage. The CC&R's also discuss the restrictions placed on owners of lots with designated greenbelt areas. [See the sidebar here - ed]

"In addition, there are three "recreation area" greenbelt areas that can be accessed by members of our community (noted in red on the map – on both sides of Island Way and a bit south in case you have only the black and white version)."

### **Rules for Greenbelts from the** Subdivision maps cover sheet.

Those certain strips of land shows here as "greenbelt Areas" and "Recreation Areas" are hereby reserved for the use of all land owners of any parcel of land which is a portion of Ice Lakes Subdivisions No. 1 and No. 2, any re-subdivision thereof, Serene Lakes Unit 1, plus any subsequent unit hereof. The use of these areas shall be in accordance with the condition as set forth hereinafter.

Conditions Affecting "Greenbelt Areas" and "Recreation Areas"

The Owner of such property:

1. is prohibited form erecting or causing to be erected any permanent structure thereon.

2. is prohibited from cutting, benching, or regarding said property without written authorization of the county of Placer.

3. May plant, landscape or otherwise improve the appearance of said property provided such work does not conflict with tor violate any conditions prescribed in the foregoing subparagraphs (1) & (2)

4. Shall not inhibit or restrict ingress and egress through said areas by persons holding the legal right to do so by virtue of this map.

5. Shall not remove or harm any tree or other work planted or constructed thereon, except with permission of the county of Placer.

# Progress at the Lodge

Happy New Year from the Tuckers and Aus from the Lodge (formerly known as Ice Lakes Lodge).

As we reflect on our remodeling experiences of 2015 we wanted to share with the SLPOA membership where we're at in our project to convert the Lodge into two residences as of January 1, 2016.

So far we have demolished walls, ceilings, and floors, and have hauled away fifteen (15) 30 yard dumpsters. Additionally we've discovered and corrected dry-rot that affected all of the support posts to the exterior decks and the roof of the port cochere.

With all of this demolition we have ended up with all sorts of surplus building materials that we will not be reusing in our remodel, so if you're thinking about doing some remodeling yourself we have or will have double pane windows and sliding glass doors, fiberglass bath tubs, pine wainscot, and tempered glass panels that were used on our deck railings. I have also attached some photos of our progress that might be of interest.

Another thing that we've discovered in our ownership of the Lodge this last year, after speaking with the water district manager, is that while some of the lots around the lakes [mostly on the east side] do not abut the lakes, the Lodge does. This confusion has given some community members the belief that there's a public right away behind and around our Lodge property. Since there isn't we respectfully request that people respect our private property rights by not intruding on our private beach.

We look forward to sharing more exciting news with you as we continue our remodeling project....

contact information is up to date. If there is a problem at your cabin this winter, you will want us to get in touch with you.


The SLPOA board hopes to see you up on the summit enjoying our winter wonderland or at a SLPOA sponsored function this summer funded by your membership dues.
